UNDERTAKING BY SHOP OWNER / TENANT

The tentage to be installed shall be within the shop-front only.

- 1. The maximum length of tentage from the shop-front shall not exceed 4 metres from columns / beams and the width shall be within the shop front columns. The height of the tentage shall not be higher than the ceiling of the shop-front.
- 2. The minimum passage width of 1 metre shall be maintained at all times to facilitate safe and unhindered pedestrain movement.
- 3. The maximum period allowed for the tentage is 14 days proceeding the major festive seasons.
- 4. All merchandise shall be neatly stacked within the approved tentage area and the stacking shall not exceed 2 metre height.
- 5. Permit must be displayed at shop front.
- 6. The applicant shall ensure the cleanliness of the approved area and the surrounding area at all times during the period approved.
- 7. The applicant shall ensure no excessive noise which would cause annoyance to the residents.
- 8. Sub-letting of the shop front is strictly prohibited and all merchandise displayed must be related to the shop approved trade and no cooking is allowed.
- 9. The applicant shall solely be responsible and shall pay all necessary expense for any loss or damage whatsoever and howsoever caused to the said property at the said shop front, its surrounding and / or adjacent buildings arising as a consequence of or in connection with the granting of this permit and irrespective of whether or not there is negligence on the part of the applicant.
- 10. No tapping of water or electricity is allowed from the common area.
- 11. The applicant shall pay a Temporary Occupation Licence (TOL) of \$25/ per square metre for Non-MA Member and \$20/ per square metre for MA Member plus GST at the prevailing rate and a refundable deposit of \$1,000/- upon approval of the application. The \$1,000/- deposit would be refunded to the applicant after the TOL period provided the terms and conditions mentioned above are complied.
- 12. The deposit of \$1,000/- shall be forfeited if the applicant breaches the terms and conditions and the applicant/shop owner / tenant would be debarred for erecting any tentage for the period of one year.
- 13. The applicant shall keep Tampines Town Council indemnified against all actions, claims and demands that may be lawfully bought or made against Tampines Town Council by any person or persons on account or attributable to the use of the shop front.
- 14. The Tampines Town Council in its absolute discretion reserves the right to reject any application and revoke any permit granted without giving any reason. The Tampines Town Council shall not be liable for any damages arising from the rejection of the application or revocation of the permit.
