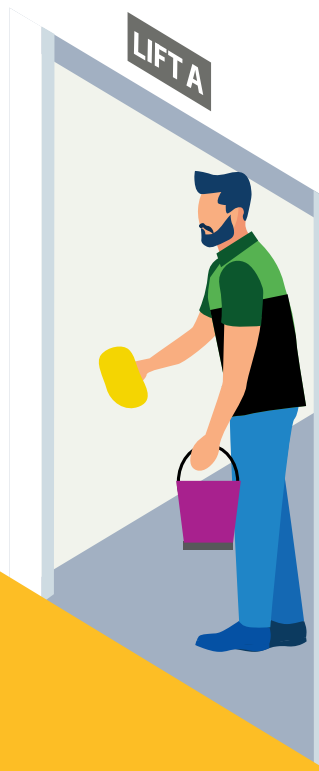

SERVICE & CONSERVANCY CHARGES (S&CC)

WHAT IS S&CC?

- S&CC is due on the first day of every month and is payable without demand (i.e. no invoice will be sent)
- Residents have one-month grace period to pay their S&CC
- Your S&CC goes towards the maintenance and upkeep of the common property and open spaces within Tampines



Routine Estate Maintenance

- Undertake conservancy and cleaning works
- Provide 24-hour essential maintenance and lift rescue services
- Landscaping and horticultural maintenance
- Building, sanitary, electrical maintenance (including lifts, pumps and public lightings etc)

Cyclical Maintenance Works

- Cyclical Repairs and Redecoration (R&R) and repainting of buildings
- Re-roofing, electrical re-wiring, replacement of water tanks and pumps
- Replacement of lifts and their components



Payment Modes for S&CC

To save time and avoid overcrowding, you can make your S&CC payments via the following methods:



Cheque Payment

You can mail the cheque or drop it off at Tampines Town Council. The cheque should be crossed and made payable to 'Tampines Town Council'. The reverse side of each cheque must bear your full name and residential address.

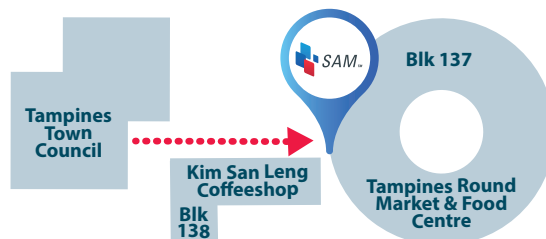
ALTERNATIVE Payment Modes for S&CC

HOW TO GET TO OUR TAMPINES HUB



Getting to OTH by Car:

The Basement 2 Car Park can be accessed by Entrance A & C, via Tampines Avenue 4 & 5 or via Tampines Walk. The Basement 1 Car Park can be accessed by Entrance B (see directions outlined above)



Getting to OTH by Train:

Alight at Tampines MRT Station (DT32, EW2) (approx. 5 min walk)



Getting to OTH by Bus:

Bus stops A & B - 3, 10, 20, 22, 23, 31, 34, 39, 65, 67, 292, 293
Bus stop C - 22, 293

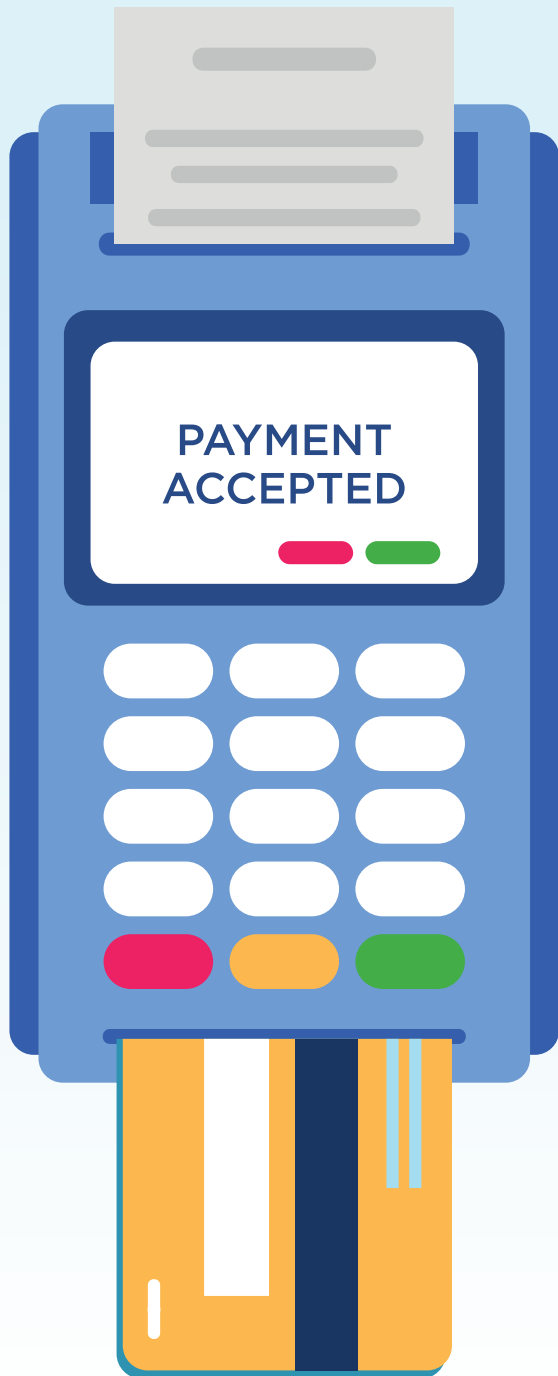


Getting to OTH by Taxi:

Things to Note Regarding S&CC Payments



GIRO deduction

- GIRO deduction is made on the 28th of every month. If deduction is unsuccessful, a second GIRO deduction will be made on the 7th of the following month*

**Late payment fee may incur if both deductions are unsuccessful on the 10th of the following month*

Late payment penalty

- Impose late payment penalty fee of 2% per month of outstanding S&CC for residential units and 5% per month of outstanding S&CC for commercial units
- Disallow use of common facilities except on compassionate grounds such as funeral wake
- Take private summons to recover arrears
- Recover all legal and administrative costs incurred
- Work with HDB to tag the sale of season parking tickets

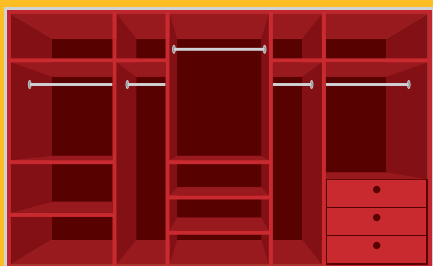

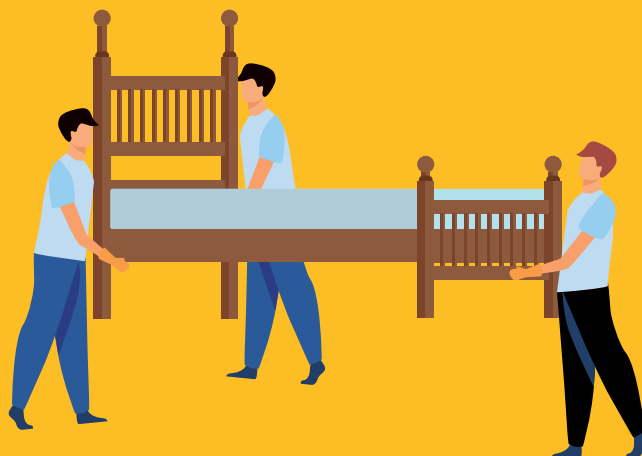

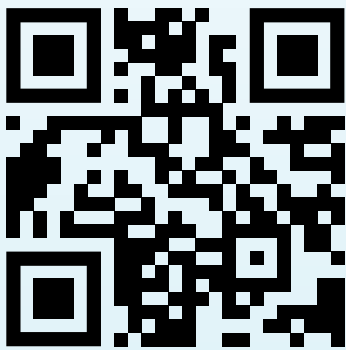
